Taking into consideration the magnitude, sensitivity and the variety of issues involved in this Public Interest Litigation, which is continuing since long and in which a very detailed order has been passed by this Court on 05.11.2019, we direct the State to submit chart-wise description of issues raised in this PIL, directions issued and the compliances made.

In addition to above, the State shall also submit before the Court complete list of references which are pending either before the Collector or before the Board of Revenue arising out of the direction issued in this case towards removal of encroachments.

We also propose to constitute a five member Co-ordination Committee for better co-ordination of the work towards implementation of the directions issued by this Court. For this purpose, we request learned Additional Advocate General and learned Additional Solicitor General to suggest the names of the members within a period of ten days.

List this case on 20.01.2022 for passing necessary orders towards constitution of Co-ordination Committee.
