1. The Court has been apprised that the divergent view of various High Courts on the issue of faceless assessment is pending before the Supreme Court.
2. The writ petitions are adjourned *sine die*.
3. The interim order passed in the present writ petitions is modified to the extent that any proceedings taken hereinafter by the department shall be subject to outcome of the writ petitions. In the eventuality of demand being created on culmination of the proceedings, no coercive measures shall be taken against the petitioners.
4. The parties shall also be at liberty to move an application for listing of these petitions after decision of the Supreme Court.
