1. Heard.
2. Issue notices to the respondents of appeal as well as of stay application and also of the applications (I.A. Nos. 1/2026 & 2/2026) by both modes i.e. ordinary process and registered post.
3. One set be given 'dasti' to the learned counsel for the appellant.
4. Let, record be summoned from the learned Tribunal.
5. In the meantime, the effect and operation of the impugned award dated 19.12.2025 passed by learned Motor Accident Claims Tribunal No.2, Kekri, District Ajmer in Claim Case No. 30/2023

shall remain stayed, provided the appellant-Insurance Company deposits the entire awarded amount with the concerned Tribunal within a period of four weeks from today.

6. On such deposit being made, the claimant-respondent shall be at liberty to move an application before the learned Tribunal for disbursement of 50% of the said amount, on furnishing an undertaking on oath that in case, appellant succeeds in the appeal, the said amount shall be refunded by the claimant along with interest @ 6% per annum.

7. The balance 50% amount shall be deposited in the Fixed Deposit with a Nationalized bank initially for a period of one year, which shall be renewed from time to time.

8. Heard on application (I.A. No. 03/2026) for dispensing with the filing of certified copy of the impugned award dated 19.12.2025.

9. Learned counsel for the appellant submits that he has already filed the certified copy of impugned award dated 19.12.2025.

10. Therefore, the defect has been removed.

11. Accordingly, the application (I.A. No. 03/2026) stands disposed of.

12. List the matter along with S.B. Civil Miscellaneous Appeal No. 1247/2026.
