1. The matter comes upon an application (I.A. No. 01/2026) for impleading respondent Nos. 8 & 9, who are Assistant Engineer and Superintending Engineer, Jaipur Vidyut Vitran Nigam Ltd., Kotputli who were already defendants in the suit, which has been decided by learned District Judge, Kotputli-Behror vide judgment and decree dated 17.02.2026.
