**D.B. Civil Writ Petition No. 5865/2024:-**

One more opportunity to file application for substitution of legal representatives is prayed for.

In the interest of justice, last opportunity of three weeks is granted to do the needful, failing which the writ petition shall stand dismissed automatically without further reference to the Bench.

**D.B. Civil Writ Petition No. 5389/2024:-**

Heard on application (1/2024) for substitution of legal representatives of deceased respondent.

Issue notice to the legal representatives named in the application on payment of PF within two weeks, returnable within three weeks.

Non-payment of PF, as directed, shall entail automatic dismissal of the writ petition without further reference to the Bench.

List this bunch of petitions after six weeks.

On the next date of hearing, the Registry shall clearly submit a note with regard to service of notice on respondents in each of the petition in the bunch.
