1. The interlocutory application (I.A. No. 01/2026) has been filed by the petitioners seeking correction of the order dated

19.03.2026 passed in S.B. Civil Writ Petition No. 5141/2026.

2. Learned counsel for the petitioners submits that due to an inadvertent error, in paragraph No. 1, the post has been mentioned as "Lab Technician" instead of "Lab Assistant". He further submits that due to typographical error in the last paragraph, i.e., paragraph No. 4, the word "petitioner" has been mentioned instead of "petitioners".

3. In view of the submissions made and for the reasons stated in the application, the application (I.A. No.01/26) is allowed. It is directed that in the order dated 19.03.2026 passed in S.B.
