IN S.B. Criminal Misc. Petition No.1930/2024:-

1. Learned counsel for the petitioners submits that for the same
issue, several FIRs have been registered at the instance of the
complainant as well as his son. He submits that after thorough

investigation, a negative final report has been submitted by the Investigating Agency. He submits that with regard to same allegations, another FIR No.388/2022 has been registered against the petitioners at Police Station Khetri, District Jhunjhunu. He submits that FIR No.388/2022 has been assailed by the petitioners by way of filing Criminal Misc. Petition No. 7926/2022 wherein, vide order dated 14.09.2022 interim protection was granted to the petitioners.

2. In view of the above submissions, issue notice to respondents.

3. Learned State counsel accept notice on behalf of respondent No.1-State. Copy of this petition has already been supplied in his office.

4. Mr. Pradeep Singh, Advocate has put in appearance on behalf of the complainant-respondent no.2. Thus, Notice need not be issued to such respondent.

5. Learned counsel for the petitioners is directed to supply copy of this petition to counsel for complainant/respondent No.2.

6. List on 06.05.2024 along with S. B. Criminal Misc. Petition No.7926/2022. Till the next date of hearing, petitioners shall not be arrested in connection with FIR No.388/2022 registered at Police Station Khetri District Jhunjhunu. It is made clear that petitioners shall fully co-operate with the investigation of the case.
