Application (No.1/2020) for amendment in D.B. Civil Writ Petition No.15097/2019 is dismissed as not pressed.

Application (No.1/2019) for vacating stay in D.B. Civil Writ Petition No.15097/2019 is also rejected as the petitions are being listed for final hearing.

Application (No.1/2024) for amendment of the writ petition in D.B. Civil Writ Petition No.17027/2019 is allowed as unopposed. Amended copy of the petition be filed and supplied to respective respondents within a week.

Learned counsel for the respondent submits that reply, which has already been filed, takes care of the pleadings made in the amendment.

An application for interim relief has been filed by the petitioners to which reply is awaited from the side of the respondent No.4, though copy of reply, proposed to be filed, has already been supplied to learned counsel for the petitioners.

we are of the view that these petitions have remained pending since long and earlier also when prayer for interim was made, this Court disposed of the application and set down the matters for final hearing which, however, could not be concluded for one reason or the other.

Keeping in view the aforesaid factual background of the cases, we are not inclined to pass any interim order in these matters at this stage, but to set down these matters for final hearing so that this batch of petitions itself could be finally disposed of on merits.
