Learned counsel for the petitioner submits that order dated 29.01.2024 (Annexure-3) passed by learned Gram Nyayalaya Roopwas, District Bharatpur cannot be challenged by way of revision petition. Counsel further submits that learned revisional court has no jurisdiction to entertain revision petition against the order dated 29.01.2024 passed by learned Gram Nyayalaya

Roopwas, District Bharatpur. Counsel further draws attention towards provision of Section 33 of Gram Nyayalaya Act, 2008. Sub-Section 3 of Section 33 provides that subject to sub-Section (2) an appeal shall lie from any other judgment, sentence or order of a Gram Nyayalaya to the Court of Session.

Issue notice to the respondents.

Learned State counsel accepts notice on behalf of respondent No.1.

Copy of the criminal writ petition has already been supplied in his office.

Let notice be issued to respondent Nos.2 to 6 through both the process, returnable by next date of hearing. Requisites be filed within a period of seven days, failing which the criminal writ petition shall stand dismissed automatically without further reference to the Bench.

If requisites are filed within time, list this case on 26.07.2024. Till next date of hearing, further proceedings of the trial court shall remain stayed.
