Pursuant to order of this Court, Ms. "K" is produced by Shri Ashok, SI, Police Station Patrakar Colony and Ms. Neha (2544) before this Court.

Indisputably, she is minor.

On interaction, she stated that she does not want to go to her parental home but, wants to reside at Nari Niketan, Gandhi Nagar.

In view thereof, this habeas corpus petition is disposed of in following terms:

- (1). The concerned police officials, who are present today in the Court, are directed to admit the Ms. "K" in Nari Niketan, Gandhi Nagar.
- (2). Ms. "K" will remain in Nari Niketan till she attains the age of majority. However, if during the intervening period, the Ms. "K" wishes to go with her parents, she may be sent with them after necessary verification.
- (3). Superintendent /In-charge/ Caretaker, Nari Niketan, Gandhi Nagar is directed not to permit anyone else to meet the Ms. "K" other than her parents.

A copy of this order be provided to the learned Government Advocate-cum-Additional Advocate General and a copy be also sent to the Superintendent /In-charge/ Caretaker of Nari Niketan, Gandhi Nagar for necessary compliance.

Pending application(s), if any, also stands disposed of accordingly.
