1. This habeas corpus petition has been filed on behalf of the
petitioner–Rajesh Bhat.

2. Today Mr. Surendra Singh (C.I.) Police Station-Khora Beesal, Jaipur, has produced the corpus before us. The corpus is minor, who is below 18 years of age and this fact has been confirmed by counsel for the petitioner as well as by learned Government Advocate-cum-Additional Advocate General.

3. We have interacted with the corpus and she has firmly stated before us that she is not in any illegal detention. She wants to go and live with her father-Rajesh Bhat, who is present in the Court.

4. Considering the statement made by the corpus before us and also considering the fact that she is minor and below 18 years of age, we permit the corpus to live with her father. Custody of the corpus is handed over to her father, who is present in the Court and identified by the counsel for the petitioner as well as the concerned SHO.

5. Mr. Surendra Singh (C.I.) Police Station-Khora Beesal, Jaipur is directed that no harm should be caused to the corpus by anyone while going with her father.

6. In that view of the matter, this habeas corpus petition is disposed of.
