Learned counsel for the petitioner submits that on 25.11.2024, E-tender No.15/2024-25 was issued by the respondent No.4 wherein annual bids were invited for supply of SNIBE Reagents and other consumable items used in machine Maglumi-800. It is submitted that petitioner has also submitted his technical bid but, same was rejected vide Technical Evaluation Report dated 17.01.2025. Counsel submits that the said report was assailed by the petitioner by way of First Appeal wherein appeal was allowed and vide order dated 19.02.2025, petitioner was declared qualified. Thereafter, order dated 19.02.2025 was assailed by other participant-respondent No.6 by way of Second Appeal wherein order passed by the First Appellate Authority is quashed and set aside.

Matter requires consideration.

Issue notice to the respondents, through both the process, returnable by next date of hearing.

Requisites be filed within a period of two weeks, failing which, this petition shall stand dismissed automatically without any further reference to the bench.

If requisites are filed within given time, list this case after eight weeks.

Meanwhile, further proceedings in respect of E-tender No.15/2024-25 shall remain stayed.
