HON'BLE MR. JUSTICE SAMEER JAIN**Order****29/04/2026**

In the instant matter, learned counsel for the petitioners has apprised this Court that a review application, filed by the petitioners, is presently pending adjudication before the learned Appellate Tribunal.

Learned counsel submits that by invoking the extraordinary writ jurisdiction of this Court when the said review petition is *subjudice*, the petitioners have inadvertently resorted to pursuing a parallel remedy.

In light of the aforesaid factual position, learned counsel for the petitioners seeks permission to withdraw the present writ petition, with a prayer seeking liberty to pursue and avail the remedy of the review application pending adjudication before the learned Appellate Tribunal.

Accordingly, the present writ petition is dismissed as withdrawn, with the liberty as prayed for being granted. Pending application(s), if any, shall stand disposed of.
