1. Heard.
2. Issue notice to all the respondents of appeal as well as of stay application by both modes i.e., by ordinary process as well as by registered post, returnable within three weeks.
3. Requisites be filed within one week.
4. Record of the Court below be summoned.
5. List the matter along with S.B. Civil Miscellaneous Appeal No. 1885/2026.
6. Till the next date of hearing, the effect and operation of the impugned award dated 13.03.2026 passed by learned Motor Accident Claims Tribunal, Tonk (for short learned 'Tribunal') in Claim Petition No. 376/2023 shall remain stayed, provided the appellant-Insurance Company deposits the entire awarded amount with the concerned learned Tribunal within a period of four weeks from today.
7. On such deposit being made, the said amount shall be deposited in the Fixed Deposit with a Nationalized Bank initially for a period of one year, which shall be renewed from time to time.
8. However, respondents-claimants shall be at liberty to move appropriate application for disbursement of the amount of compensation deposited by the appellant-Insurance Company.
