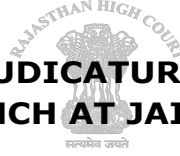




**HIGH COURT OF JUDICATURE FOR RAJASTHAN

At the outset, learned counsel for the appellant submits that he is not pressing the present appeal, at this stage, because the temporary injunction application is still pending consideration before the learned Trial Court. He alternatively prays that a direction may kindly be given to the learned Trial Court to decide the pending temporary injunction application within a particular time frame.
2. Considering the innocuous prayer made by the appellant, the present appeal is dismissed as withdrawn with a direction to the learned Trial Court to decide the pending Temporary Injunction Application No.35/2025, independently, without being influenced by the impugned order dated 27.02.2026 passed by the learned Additional District Judge, No.3, Jaipur Metropolitan-II, Jaipur, preferably within a period of one month from the next date fixed in the temporary injunction application.
4. In view of the above, the present civil miscellaneous appeal is disposed of with the aforesaid directions.
5. Any other pending application(s), if any, stand disposed of.
