1. Learned counsel for the petitioners has submitted that the instant lis is no more *res integra*, and is already addressed by the ratio encapsulated in **S.B. Civil Writ Petition No.6034/2026** titled **Dayanand Bharia and Ors. Vs. State of Rajasthan and Ors.** decided vide judgment dated 02.04.2026.
2. Learned counsel for the respondent-State AAG Mr. S.S. Naruka has not disputed the said fact.
3. Accordingly, the present writ petition is disposed of in light of the ratio of **Dayanand Bharia (supra)** and **Lakhpatt & Ors. V.**

State of Rajasthan: S.B.CWPNo.5692/2026, which shall be squarely applicable to the instant petition. The petitioners are directed to mark their attendance on 04.05.2026 at or around 11:00 AM before the competent/appropriate authority. It is directed that the said authority shall pass a speaking order, strictly in accordance with law, within an upper limit of 15 days from the date of petitioners being present.
