1. Mr. Vinod Kumar Singhal, learned counsel for the petitioner, at the very outset, submits that the appeal bearing Revenue Appeal No.73/2021 (Annexure-2) filed by the respondents No.1 and 2 - State, challenging the order dated 10.04.2018 (Annexure-1) passed by the Sub-Divisional Officer, Thanagazi, District Alwar, is pending for the last five years before the Revenue Appellate Authority (**RAA**), Alwar, and no interim order has been passed therein. However, despite the said fact, neither the appeal is being decided nor the order dated 10.04.2018 is being executed.

2. Thus, learned counsel for the petitioner submits that he may be granted liberty to file an appropriate application before RAA, Alwar, seeking expeditious disposal of the abovementioned appeal.

3. Considering the limited submission so made and without delving into merits of the matter, the present writ petition is disposed of with liberty to the petitioner to file appropriate application seeking early disposal of the appeal before the RAA,

Alwar, in Revenue Appeal No.73/2021 (Annexure-2) titled as State of Rajasthan & Anr. Versus Girraj Prasad & Ors., and in the event of any such application being filed by the petitioner along with the certified copy of this order, the same be considered and decided by the RAA, Alwar, strictly in accordance with law and as early as possible.

4. With the aforesaid directions, the present writ petition stands disposed of.

5. Pending application(s), if any, also stand disposed of.
