Counsel for the applicant submits that the present matter was listed on 29.04.2026 alongwith other connected matters wherein this Court passed the order for listing the matters on 11.05.2026 and the interim order passed by this Court was ordered to be continued.

Counsel further submits that due to inadvertence in the present matter, the interim order was not passed.

The interim order passed in one of the similar matter-D.B. Civil Writ Petition No.10472/2025 on 15.07.2025 reads as under:-

"Counsel for the petitioner submits that the issue involved in this writ petition has been considered by the Coordinate Bench of this Court in the matter of Rohan Malhotra Vs. The State of Rajasthan & Ors. (D.B. Civil Writ Petition No.6950/2025) vide order dated 02.07.2025.

In that view of the matter, issue notice to the respondents returnable on 25.08.2025.

Meanwhile, we are inclined to stay demand/recovery of road tax from the petitioner.

However, petitioner shall submit undertaking within a period of one month before the Respondent No.2-District Taxation Officer that in the event he fails and does not get any relief, he shall pay the entire tax within a period of one month.

The respondents are directed to release the vehicle of the petitioner seized by them immediately after verifying the ownership documents.

List on 25.08.2025."

In that view of the matter, it is directed that the aforesaid interim order shall also be operative in the present matter and the respondents are directed to release the vehicle of the petitioner seized by them immediately after verifying the ownership documents.

List this matter alongwith D.B. Civil Writ Petition No.6122/2026.

The application Nos.1/2026 & 2/2026 stand disposed of.
