1. Learned counsel for the petitioners submit that in the case where interim protection is not granted, the petitioners are apprehend disconnection of their long-standing and ongoing electricity connections. They further submit that in matters of a similar nature, namely, conversion of electricity connections from Agricultural (AG) category to Non-Domestic Supply/Service (NDS) category, the rights of the petitioners therein have been protected by this Court by way of various separate interim orders. They,

therefore, seek parity and pray that similar protection may be extended to the petitioners herein as well.

2. Heard.

3. Today, on account of paucity of time, it is not possible to hear the matters in detail. Therefore, while reserving the rights of the respondents to make her submissions on the stay applications as well as in the writ petitions, and in order to maintain parity with similarly situated parties, this Court considers it appropriate to protect the rights of the petitioners herein.

4. Accordingly, it is directed that only till the next date of hearing, the ongoing electricity connections of the respective petitioners shall not be disconnected.

5. Office is directed to tag the matter along with S.B. Civil Writ Petition No. 8808/2026, 8580/2026, 8581/2026, 8583/2026, 8579/2026, 8582/2026, 8048/2026, 14066/2025, 10332/2025, 220/2026 and 477/2026.
