The present criminal miscellaneous petition has been filed by the petitioner seeking quashing of FIR No.0011/2026 dated 03.01.2026 registered at Police Station Pratap Nagar, District Jaipur City (East), for the alleged offences punishable under Sections 420, 406, 467, 468, 471 and 120-B of IPC, 1860.

Mr. Sanjay Gangwar, learned counsel for the petitioner submits that even if the contents of the impugned FIR are taken on the face, it fails to disclose any offence being committed by the petitioner and the entire controversy is purely of a civil nature, which is evident from the bare perusal of M.O.U. dated 15.01.2024 (Annexure-2) entered into by the petitioner with the complainant - respondent No.2.

Learned counsel for the petitioner further submits that for the very same controversy, notice under Section 21 of the Arbitration and Conciliation Act, 1996 (hereinafter referred as '**the Act of 1996**'), dated 27.12.2025 was served by the complainant - respondent No.2 upon the petitioner, which was even duly replied by the petitioner on 21.01.2026. Thereafter, even an application under Section 9 of the Act of 1996 has been filed by the complainant - respondent No.2 before the learned Commercial Court No.1, Jaipur Metropolitan-I, Jaipur, being Arbitration Application No.04/2026 on 05.01.2026 and the same is pending consideration.

Taking note of the above, issue notice to the respondents.

Learned Public Prosecutor accepts notice on behalf of respondent No.1.

Let notice be filed for respondent No.2, returnable within four weeks. Notice be also sent through registered post in addition to the normal process.

List the matter on 23.07.2026.

In the meanwhile, further proceedings in respect of the impugned FIR No.0011/2026 dated 03.01.2026 registered at Police Station Pratap Nagar, District Jaipur City (East), shall remain stayed.
