1. Learned counsel for the petitioner submits that the petitioner was initially appointed as Nurse Grade-II vide order dated 15.02.2016 and she duly joined her duties at Govt. Mahila Chikitsalaya, Ajmer. Learned counsel submits that thereafter, the petitioner was assigned the charge of the Record Room and was continuously discharging her duties as In-charge thereof. It is further submitted that vide office order dated 13.10.2025, Shri

Radheyshyam Chaturvedi, Nursing Officer, was posted as Ward In-charge of the record room. Learned counsel submits that on 05.01.2026, charge of the record room was handed over to Shri Radheyshyam Chaturvedi; however, no order was issued directing the petitioner to resume or join her duties elsewhere. Later on notice has been issued to the petitioner alleging that she is not appearing on duties. Learned counsel submits that since no order has been passed in respect of the petitioner, therefore, the petitioner is not aware, where she has to join her duties.

2. Issue notice to the respondents through both the process, returnable on the next date of hearing.
3. Requisites be filed within a period of two weeks, failing which this petition shall stand dismissed automatically without any further reference to the Bench.
4. If needful is done within given time, list this matter after eight weeks.
5. Meanwhile, as an interim measure, the petitioner is directed to appear on or before 16.05.2026 before respondent No.5 and place a certified copy of this order before him. Upon such appearance, respondent No.5 shall pass appropriate orders regarding the petitioner's joining and posting.
