IN D.B. Habeas Corpus Petition No.186/2022:-

Mr. Ram Prakash, Additional Police Inspector, Civil Rights Police Headquarter, Jaipur and Ms. Gayatri, C.I. Civil Rights, SHO Jaipur are present in person, who have produced the compliance report before the Court, which is taken on record.

It is intimated by the Police Officials that all efforts are being taken to trace out the missing child. As there was counter allegation by the couple with regard to kidnapping of child, Police had investigated and has interrogated all relatives and has also taken the CDR of the petitioner as well as respondent No.7. It is informed that they will be looking into all other aspects of the matter.

IN D.B. Habeas Corpus Petition No. 58/2021:-

Four years child is missing since last more than two years and child has not been traced. It is informed that Police has taken tower location of all persons who could have been there at the place where the child went missing and have also sent it to the Cyber Cell.
