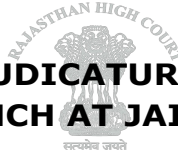

*"It is, therefore, most respectfully prayed that the Hon'ble Court may kindly be pleased to allow the present Writ Petition and pass directions to the Respondent No. 3 Election Officer to forthwith declare the Petitioner elected on the post of Sarpanch, Gram Panchayat Badalya, Panchayat Samiti Ajmer Rural, Tehsil & District Ajmer. Any other appropriate order or direction which this Hon'ble Court may consider just and proper in the facts and circumstances of the case may also kindly be passed in favour of the humble petitioners."*

**In S.B. Civil Writ Petition No. 10148/2024:**

*"It is, therefore, humbly prayed that this Writ Petition may kindly be allowed and the impugned judgment dated 29.05.2024 (Annexure-7) passed by Learned Additional Chief Judicial Magistrate First, Ajmer in Case No 159/2022 titled Sarju Devi Versus Chief Election Officer Panchayat (Ajmer) and Ors may kindly be quashed and set aside. Any other appropriate relief which this Hon'ble Court deems just and proper in the facts and circumstances of the case may kindly also be passed in favour of the Petitioner."*

At the outset, learned AAG, Mr. Kapil Prakash Mathur has submitted that tenure in question for the post of Sarpanch is already over, during the currency of the present petitions. Therefore, the instant petitions are rendered infructuous.

Accordingly, keeping the point of law open, the present writ petitions are dismissed as rendered infructuous. Pending applications, if any, shall stand disposed of.
