Order

1. Applicants in the above bunch before us seek recalling of the order dated 01.09.2025 and consequently restoration of the respective writ petitions to their original numbers for adjudication on merits in light of the amendment which was introduced by the Finance Act, 2026.
2. At the very threshold learned counsel for the applicants has candidly pointed out that similar applications filed in certain other matters were disposed of by Co-ordinate Bench of this Court, vide order dated 30.06.2026, which reads as under:-

"1. The Department has filed an application for recalling of the order passed by us whereby the writ petition was disposed of. It is stated that as the Hon'ble Supreme Court has set aside the orders passed in appeal on 10.04.2026 in the case of **Income Tax Officer, Ward 2(1), Chandigarh & Ors. vs. Tej Pratap Singh** (Diary No.2196/2026), the orders may be recalled.

2. The orders passed by this Court dated 01.09.2025 in the concerned writ petition has been challenged in appeal before the Hon'ble Supreme Court and the SLPs are still pending. In these circumstances, therefore, mainly on the basis of another order passed in relation to another case, this court would not recall its earlier order. As the SLP against the order passed by this Court is pending before the Hon'ble Supreme Court, the application is thus found to be misconceived.

3. In view of the judgment passed by the Hon'ble Supreme Court on 10.04.2026, the Department may move appropriate application for disposal of the SLPs and if a similar order is passed by the Hon'ble Supreme Court, the writ petitions would automatically stand revived or revival order may be sought from the Court.

4. Accordingly the present miscellaneous application is dismissed with the aforesaid observations.

5. However, it is being prayed by the learned counsel for the applicant(s) that they may be allowed to file photocopy of the certified copy originally filed and the certified copies may be allowed to be handed over back to the applicant(s) for filing subsequently as and when required.

6. The prayer made is allowed.

7. All other application(s), if any, stand disposed of."

3. Apropos, learned counsel for the applicants submits that all these applications be also disposed of accordingly.

4. In view of the aforesaid statement made by learned counsel for the applicants, all the above titled applications are also disposed of in terms of order dated 30.06.2026, as above.
