Learned counsel for the petitioners, at the very outset, has placed reliance upon the order dated 22.06.2026 passed by this Court in ***S.B. Civil Writ Petition No. 10692/2026*** titled as ***Hashmat Alam & Ors. Vs. Ad-Hoc Committee & Anr.***, the relevant and operative portion of which reads as under:-

"16. Taking note of the above, at this stage, while granting liberty to learned counsel for the respondents to file detailed reply to the writ petition, the respondent association - JDCA, is restrained from holding its annual general meeting scheduled to be held on 23.06.2026.

However, it is clarified that in case, it chooses to allow the excluded members to clear their subscription

dues, it would be at liberty to proceed ahead to hold its annual general body meeting in accordance with the Constitution of the JDCA and the provisions of the Act of 2005.

17. *Learned counsel for the petitioners also seek time to file reply to the preliminary objections as raised by the learned counsel for the respondents.*

18. *List the matter on 08.07.2026."*

Taking note of the same, issue notice to the respondents through ordinary post as well as registered post.

Notices be given "Dasti" to the learned counsel for the petitioners.

List the matter on 08.07.2026 along with S.B. Civil Writ Petition No. 10692/2026.

In the meanwhile, the respondent No.3- JDCA, is restrained from holding its annual general meeting scheduled to be held on 23.06.2026.

However, it is clarified that in case, it chooses to allow the excluded members to clear their subscription dues, it would be at liberty to proceed ahead to hold its annual general body meeting in accordance with the Constitution of the JDCA and the provisions of the Act of 2005.
