Vide order dated 10.12.2024 it was directed as under:-

Heard on application for condonation of delay in filing the restoration application.

Taking into consideration the short period of delay and cause shown in the application, we are inclined to condone the delay. Delay is accordingly condoned.

The application under Section 5 of the Limitation Act is allowed. Heard on prayer for restoration.

Taking into consideration the cause shown in the application, we are inclined to allow the prayer for restoration.

Accordingly, the restoration application is allowed. D.B. Special Appeal (Writ) No.989/2023 is restored to its original number, subject to payment of cost of Rs. 5,000/- to be deposited with the Rajasthan State Legal Services Authority within a period of one month.

Learned counsel appearing on behalf of the applicant submits that on account of non-communication the amount could not be deposited within the period as laid down hereinabove and the same was deposited subsequently on 31.01.2025. The delay in depositing the amount may be condoned and the appeal be restored to its original number.

Considering the aspects, we condone the delay in depositing the amount, the Appeal No.989/2023 is restored to its original number.

Miscellaneous application is accordingly allowed.
