1. On previous date i.e. 24.06.2026, an opportunity to file reply
to the writ petition so also to stay application was granted to
Additional Advocate General, who appeared on behalf of
respondents-State Authorities, however as per record, no reply
has been filed nor anyone has put in appearance for and on behalf
of respondents-State Authorities.
2. Counsel for petitioner prays for grant of an interim relief.

3. Counsel for petitioner submits that petitioner has been allotted a post of Senior Resident in Department of Obstetrics and Gynaecology at RUHS College of Medical Sciences, Jaipur. Petitioner is stated to continue his Senior Residency at Government Medical College, Tonk and prayed to relieve her, in order to join at RUHS College of Medical Sciences, Jaipur, but respondents have not relieved the petitioner. The last date of joining is stated to be upto 30.06.2026. Reliance has been placed on the interim order dated 20.02.2026 passed by the Coordinate Bench in S.B. Civil Writ Petition No.3529/2026, directing the respondents to issue the relieve order to the petitioners to join Senior Residency and it has been argued that the same analogy apply to the petitioner herein as well.

4. Having considered the factual matrix and the order dated 20.02.2026 passed by the Coordinate Bench, in order to maintain comity and parity, this Court deems it just and proper to grant interim order, subject to final decision of writ petition that respondents shall forthwith relieve the petitioner in order to join on the post of Senior Resident at RUHS College of Medical Sciences, Jaipur.

It is made clear that petitioner would join her Senior Residency at RUHS College of Medical Sciences, Jaipur at her own risk and consequences, subject to final adjudication of this writ petition and the interim order shall not create any equity in her favour.
