Order

1. After arguing for considerably long time, learned counsel for the petitioners, on instructions, seeks permission to

withdraw these writ petitions with liberty to pursue their rights before the Sub Divisional Officer.

2. It goes without saying that the Sub Divisional Officer shall decide the suit as per the directions given by Revenue Appellate Authority to the extent of shares of the parties, as per remand directions. It also goes without saying that while doing so, SDO shall, at the time of passing final decree take into consideration proposal with regard to division of the land by metes and bounds as well as objections, if any, and shall decide the same expeditiously.

3. These writ petitions are dismissed as withdrawn with above observations.

4. Pending application(s), if any, stand(s) disposed of.
