The instant batch of petitions is filed assailing the impugned action of the respondents, as qua non-grant of information sought by the petitioner(s) under the provisions of the Right to

Information Act, 2005. The observations noted herein, be considered on *mutatis mutandis* basis on all the petitions connected herein.

The preliminary ground due to which judicial interference of this Court is warranted in SBCWP No. 11288/2025 is that on 18.11.2024 State Public Information Officer refused to grant information to the petitioner, pursuant to his application dated 14.10.2024; against which the First Appeal as preferred by the petitioner was dismissed on 15.01.2025 and the Second Appeal preferred by the petitioner was dismissed on 19.05.2025, by the Rajasthan State Information Commissioner, in a cursory, non-speaking manner, sans dealing any grounds as furnished by the petitioner(s)/appellant(s), in the appeal before the competent authority.
