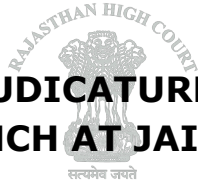

HON'BLE MR. JUSTICE ANUROOP SINGHI
Order

29/04/2026

1. Considering the fact that the relief prayed for in all the present writ petitions is similar but for the minor variations and that the matters warrant adjudication on common issues with respect to facts applicable to the respective petitioners, for the sake of convenience, the Civil Writ Petition No.5590/2023 titled as Mool Chand and Others Vs. State of Rajasthan and Others, is taken as the lead matter and the prayers made therein are reproduced as under:-

*"It is, therefore, most humbly and respectfully
prayed that this Hon'ble Court may kindly be pleased to
accept and allow this writ petition and-
i) by appropriate writ, order or direction in the nature
thereof, the entire record be called for from the
respondents pertaining to the land in question;*

ii) by further appropriate writ, order or direction in the nature thereof, Respondents be directed to regularize the possession of petitioners on 10 bigha of land, which is part of land bearing khasra No.315/397 situated in Village Gopalgarh, Tehsil Jamwa Ramgarh, District Jaipur;
iii) award costs to the petitioners; and
iv) Any other order or direction which this Hon'ble Court deem just and proper in the facts and circumstances of the case may kindly also be passed in favour of the Petitioners."

2. Bare perusal of the prayers made and the documents annexed with the writ petition, reveals that the petitioners are seeking regularization of the land on the basis of their long-standing possession on the same, in support of which, various documents have been annexed.

3. Mr. S.N. Kumawat along with Mr. Nawal Kishore Saini and Mr. G.K. Jain, learned counsel for the petitioners, submit that the petitioners have approached the respondent – Authorities on various occasions inviting their attention to the circulars issued by the State Government from time to time with respect to regularization of land in favour of the persons who are similarly situated as the petitioners, however, no final decision with respect to the regularization as sought by the petitioners has been taken by the respondents till date.

4. Thus, learned counsel make a limited prayer that the respondents may be directed to consider the representations made by the petitioners for regularization of land and accordingly, their prayer for grant of regularization be also considered.

5. The said prayer for consideration of the entitlement of the petitioners with respect to the regularization of the land on which the petitioners are claiming possession is not disputed by learned counsel for the respondents, however, he submits that the

entitlement of the petitioners would be considered based upon the facts and merits of each case and in the event, the petitioners approach the respondent – Authorities along with the relevant documents in support of their entitlement, the same would be duly considered in accordance with law.

6. Taking note of the above submissions and without delving into the merits of the matter, the present writ petitions are disposed of with the direction to the petitioners to approach respondent – Tehsildar, Tehsil Jamwaramgarh, District Jaipur, by filing their respective representations along with requisite documents/details, establishing their entitlement for seeking regularization of the land on which they are claiming possession, which would be considered and decided by the said authority within a period of six weeks thereafter, strictly in accordance with law by passing a speaking and reasoned order after granting opportunity of hearing to the petitioners.

7. With the said directions, the writ petitions stand disposed of.

8. Pending application(s), if any, also stands disposed of.

9. Needless to say, this order has been passed only to decide petitioners' representations strictly in accordance with law and in no manner is to be construed as a direction to decide the same in a particular manner.

10. Also, in the event, the petitioners are aggrieved by any decision taken by the competent authority, it will be open for them to avail remedies as available in law.
