1. Learned counsel for the petitioner submits that the petitioner-institution is a private Industrial Training Institute, duly authorized to impart vocational training to students in various trades. The grievance raised by the petitioner in the present writ petition is that the respondents have neither issued the login ID and password to the petitioner for the purpose of admissions nor provided access to the NCVT, MIS Portal of the Ministry of Skill Development and Entrepreneurship, Government of India, which is essential for conducting online admissions. She, therefore, prays that the respondents may be directed to activate the login ID of the petitioner for the academic session 2026-27/28.
2. In order to buttress her contentions, learned counsel for the petitioner places reliance upon the order passed by a Co-ordinate

Bench of this Court at the Principal Seat, Jodhpur, in ***Bright Future Pvt. ITI & Ors. v. State of Rajasthan & Ors.***¹, wherein a similar controversy was considered and interim relief was granted in favour of the petitioner therein. Learned counsel, therefore, seeks parity with the aforesaid order.

3. Heard.

4. Mr. Vishnu Dutt Shamra, appears for Mr. Bhwnesh Sharma, AAG, and accepts notice on behalf of respondent Nos. 1 and 2, thus service upon respondent Nos. 1 and 2 is complete.

5. Mr. Divyesh Maheshwari, appears and accepts notice on behalf of respondent No. 3, thus service upon respondent No. 3 is also complete.

6. Learned counsel for the petitioner is directed to supply copy of the present writ petition in the office of Mr. Bhwnesh Sharma, AAG, as well as Mr. Divyesh Maheshwari, during course of the day.

7. Let names of Mr. Bhwnesh Sharma, AAG, and Mr. Divyesh Maheshwari, be reflected in the cause-list as counsel for the respondents.

8. In view of the aforesaid submissions and with a view to maintaining consistency and judicial parity, this Court deems it appropriate to extend similar interim relief to the petitioner-institution as was granted by a Co-ordinate Bench of this Court at the Principal Seat, Jodhpur, in ***Bright Future Pvt. ITI*** (*supra*).

9. Till the next date of hearing, the respondents are directed to allow the petitioner-Institution to access the NCTV, MIS Portal for

online admission against their affiliated trade/units in the academic session 2026-27/28, if the process is going on.

10. It is made clear that the access to the web portal for the purpose of admission is provisional in nature and shall remain subject to final outcome of the writ petition.

11. It is further made clear that the instant order shall not preclude the competent authority from making joint inspection of the petitioner-institution. The joint inspection report shall be kept ready to the perusal of the Court on the next date of hearing.

12. In the meanwhile, learned counsel for the respondents are directed to file reply to the present writ petition. Upon filing the reply, the respondents shall be at liberty to file an application for vacation of stay order.

13. List the matter after four weeks.
