1. Learned counsel for the petitioners submits that the issue involved in this writ petition has been considered by the Co-ordinate Bench of this Court in the matter of **Smt. Sohan Devi Gatani College Vs. The State of Rajasthan** (D.B. Civil Writ Petition No.14613/2024) wherein on 10.09.2024, the following order was passed :-

Mr. Sandeep Taneja, learned AAG appears and takes notice for respondent No.4.

with a copy of petition along with annexures.

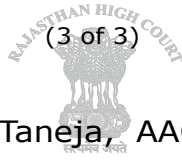
Issue notice to respondent No.3 on payment of P.F within a week, returnable in three weeks.

Registry shall publish the names of Mr. Vigyan Shah, AAG, Mr. Sandeep Taneja, AAG and Mr. Devesh Yadav, Adv. in the cause list for respective respondents.

List this case after four weeks.

In the meantime, taking into consideration submission that in identical writ petition involving identical issue in the case of KGN College of Pharmacy Vs Rajasthan University of Health Sciences - D.B. Civil Writ Petition No.6235/2024, we are inclined to pass similar interim order to the effect that in the meantime, respondent No.3 will not take any coercive action against the petitioner."

2. In that view of the matter, issue notice to the respondents.
3. Mr. Vigyan Shah, AAG appears and takes notice for respondent Nos.1 and 2, Mr. Ganesh Parihar, counsel appears and takes notice for respondent No.3, Mr. Sandeep Taneja, AAG appears and takes notice for respondent No.4 and Mr. Devesh Yadav, counsel appears and takes notice for respondent No.5.
4. In the meantime, taking into consideration the submissions and also considering the fact that identical writ petition involving identical issue is pending before this Court, we are inclined to pass similar interim order to the effect that in the meantime, respondents will not take any coercive action against the petitioners.
5. List this case along with D.B. Civil Writ Petition No.14613/2024 on 14.10.2024 after showing names of Mr. Vigyan
