**Order**

**13/11/2025**

1. Petitioner has filed the present criminal miscellaneous  
petition with the following prayer:-

"It is, therefore, most respectfully prayed that  
your Lordships may kindly be allowed this Misc.  
Petition and may kindly be directed that all the  
Criminal Cases which are pending for adjudication  
against the petitioner before the learned Special  
Court, CBI cases No. 2, 3, 4 & 5 may kindly be  
transferred in one learned Special Court, CBI cases  
for adjudication.

Further, all the criminal cases pending against  
the petitioner be decided by one learned Special  
Court, CBI Cases, Jaipur for fair and impartial  
adjudication in the interest of justice.

Any other order or direction which this  
Hon'ble Court deems fit and proper in the facts and  
circumstances of the case may also be passed in  
favour of the petitioner."

2. It is grievance of the petitioner that the CBI has  
registered several FIRs against the petitioner, which resulted in

more than 50 charge-sheets against the petitioner for which trial going on in different Courts. Details of different cases pending before different Courts have been given in the petition, which is as under:-

3. Learned counsel for the petitioner submits that as the foundational allegations against the petitioner are similar in nature and the evidence, which may be led in different cases may also be similar, therefore, it would be convenient for prosecution agency as well as for the accused-petitioner to participate in the trial of different cases effectively at one place and that would also expedite the trials.

4. Learned counsel for the CBI expresses no objection in case, trials of aforesaid pending cases are transferred to one Court.

5. In the light of above, this petition is disposed of with the direction to transfer all the pending cases mentioned in para 46 to 49 of the petition, which have been quoted in Para of this order to Special Court CBI Cases No.5, Jaipur Metropolitan-I, where the trial Court shall proceed in accordance with law.
