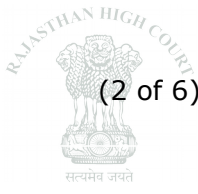

Learned counsel for the proposed applicant submits that when case was listed for consideration on various applications on the previous date of hearing on 27.01.2022, inadvertently, while

similar application was being disposed of, it could not be pointed out to the court that the application No.87409/2018 could also be disposed of in similar terms.
