Matter comes upon misc. application (IA No.1/2025) with a prayer that the office objection qua non-filing of the certified copy of the impugned award dated 19.11.2024 may be dispensed with as the appellant has filed certified copy of the award dated 19.11.2024 in another appeal bearing No.4532/2025.
