These matters have been remained pending since long.

Learned counsel for the petitioners prayed that the petitioners, under interim protection granted by this Court, have been supplying power to respondents but no payments are being made as the matters are sub-judice before the Court. Learned counsel for the petitioners would submit that at this stage, the respondents may be directed to make at least some payment towards the power already supplied over these years otherwise financial crunch may affect survival of petitioners' units, who are generating electricity through non-conventional source.

Learned Advocate General would submit that this prayer was earlier made before this Court but that was not granted and instead, this Court directed the cases to be listed for final hearing. He submits that he is prepared to argue the matter finally.

Taking into consideration that earlier also such prayer was made but this Court was not inclined to pass any such order of interim nature, we are inclined to post these cases for final hearing on 20.11.2023.

These petitions are formally admitted and listed for final hearing on 20.11.2023.
