1. Report which has been filed before this Court by respondent No. 3 reveals that there are encroachments on the road.
2. If that be so, it is expected from respondent No. 3 to take further steps. However, our directions would not in any manner disallow the respondent Nos. 5 to 33 to place their documents before the authorities to satisfy that there are no encroachments made by them. In spite thereto, if encroachments exist, same be removed leaving the area for the purpose of road.
3. Other encroachments which respondent No. 3 has identified shall be dealt with.
4. With the above observations, the present PIL stands disposed of at this stage.
