1. Instant writ petition has been filed by the petitioner with following prayer:

- "i) By an appropriate writ, order or direction in the nature thereof thereby, the respondent be directed to consider the petitioner under his main Category i.e. OBC NCL instead of Physically Handicapped (HI) Category.
- (ii) By an appropriate writ, order or direction in the nature thereof thereby, the action of the respondents may kindly be declared illegal by which considering the petitioner under

Disabled Category instead of OBC NCL (Main) Category and thereby consider the petitioner under Main Category i.e. OBC NCL Category in compliance of Guidelines as well as press note dated 12.03.2025.

iii) By an appropriate writ, order or direction in the nature thereof thereby, the respondents may kindly be directed to make pay fixation and regularize the services of petitioner on the post of Teacher Gr. III as the petitioner has completed his probation period satisfactory.

iv) Pass any other appropriate order which this Hon'ble Court may deem fit, just and proper in the facts and circumstances of the case in favour of the Petitioner."

2. Learned counsel for petitioner while referring order dated 14.10.2025 in **S.B. Civil Writ Petition No. 14954/2025 Maneesh Kumar Katara Vs. The State of Rajasthan** submits that the petitioner has applied under OBC-NCL (PH) category for the post of Teacher Grade-III Level- I and the petitioner has secured 191.4829 marks. He further submitted that the last cut-off of OBC-NCL category is 187.9231 and in case petitioner is not considered for OBC-NCL (PH) category then, he is entitled to be considered under OBC-NCL category.

3. Issue notice to respondent(s). Additional service upon standing counsel is permitted.

4. In the meanwhile, no coercive steps be taken against the petitioner.
