The instant bunch of petitions are primarily filed assailing the actions of respondents pursuant to the impugned advertisement

dated 20.06.2023 for the post of Junior Accountant and Tehsil Revenue Accountant.

In S.B. Civil Writ Petition No. 202/2025

No objections are raised by the counsel representing the parties qua the impleadment applications moved.

Therefore, for the reasons stated in the application memo, the said impleadment applications (I/A Nos. 2/2025, 3/2025 and 4/2025) are allowed.

Amended cause title be filed.

Requisites be carried out.

Considering the fact that on daily basis a number of petitions of akin nature/distinguishable *lis* however in pursuant to the same advertisement are filed and the fact that a number of impleadment applications are moved in various petitions by the successful candidates; the Court with consensus of the counsel representing various parties deems it appropriate to list the instant bunch of matters on 18.02.2025 at 02.00 P.M. for final disposal.

It is made clear that on the next date of hearing all the issues/ disputed categories/ *lis* in hand pursuant to the advertisement dated 20.06.2023 for the post of Junior Accountant and Tehsil Revenue Accountant shall be heard at length.

The Court directs Shri Sandeep Maheshwari to submit a brief synopsis (issue wise), along with the list of petition(s) that is/are ought to be taken as lead petition(s), in specific issues/ disputed categories, for efficacious adjudication of the bunch of petitions.

A copy of the aforementioned list and synopsis be supplied prior to the next date of hearing, to the counsel representing petitioners (in lead petitions).

The claim of the petitioners will be governed by the outcome of the present petitions and their rights will remain secured.
