Learned counsel for the respondent Mr. Archit Bohra has informed that connected matters are listed on 09.01.2025.

Learned counsel for the petitioner has submitted that on akin factual matrix Co-ordinate Bench of this Court has passed an interim order dated 18.12.2024 in **SBCWP No. 19101/2024** titled as **Rachana Choudhary vs. State of Rajasthan & Ors.** wherein the Court has directed the respondents to consider the candidature of the petitioner provisionally on merits for appointment on the post of Nursing Officer. Therefore, while placing reliance upon the above-cited, it is prayed that similar ratio be applied qua the petitioner in the instant matter.

Considering the facts and circumstances of the case, this Court directs the respondents to consider the candidature of the petitioner provisionally in light of the **Rachana Choudhary (supra)**. It is made clear, that final selection of the petitioner shall be subject to the outcome of the present petition.
