It is informed that the judgment passed by this Court in the case of the **State of Rajasthan & anr. vs. Suraj Mal Meena & ors.** and other connected appeals in D.B. SAW No. 1311/2025 decided on 04.04.2026 have been implemented and the Rajasthan Public Service Commission (RPSC) has already issued the advertisement allowing candidates to reappear in the Sub Inspector (SI) examination which was cancelled earlier by this Court vide advertisement dated 03.02.2021. Thus, they once have been allowed to participate in the SI examination, there is no occasion to grant further age relaxation to again appear in the subsequent RPSC examination for SI pursuant to the advertisement dated 17.07.2025.

The directions issued by the learned Single Judge would therefore have no application. The order passed by the learned Single Judge is accordingly stayed.
