1. While a specific stand of Mr. Manoj Sharma, learned AAG, is that compliance of the directions issued by this Court has been made, however, the said submission is vehemently opposed by all the learned counsel appearing on behalf of petitioners in these matters, on the ground that either the due amount or the accrued interest has not been paid.
2. Since the present matters are factual, learned counsel for petitioners are directed to file a detailed affidavit with respect to outstanding amount as on today and serve a copy of the same within a period of two weeks from today in the Office of learned AAG, to which, a counter, if so required, be filed.
3. The necessary exercise be completed within a period of four weeks in entirety and necessary requisites be filed within the said period.

4. However, it is clarified that as the said contempt petitions are pending since the years 2018 and 2019, if it is found that any of the directions issued by this Court from time to time are willfully not complied with, necessary orders would be passed on the next date.

5. Accordingly, list these matters on 13.10.2026.
