Heard Learned Senior Counsel, Mr. Sankar Kr. Deb
assisted by Learned Counsel, Mr. Saugat Datta appearing on
behalf of the petitioner.

In course of hearing, it was submitted by Learned
Senior Counsel that the petitioner being a woman, was joined as
Graduate Teacher in Kabi Nazrul Vidyabhaban H.S. School,
Teliamura, Khowai, Tripura on 16.06.2025 in pursuance of memo
dated 10.06.2025 issued by Directorate of Elementary Education.
Thereafter, she joined her duties and discharging her functions
sincerely with the utmost satisfaction of the authority. It was
further submitted that the petitioner has got two children and the



last issue was begotten on 06.01.2025 and as such, the petitioner is to take care of the said milk sucking baby. In the meantime, the respondent-Department by an office memo dated 25.06.2026 transferred the petitioner from Kabi Nazrul Vidyabhaban H.S. School, Teliamura, Khowai, Tripura to Khasnam Govt. Eng. Med. High School, Dasda, Kanchanpur, North Tripura along with another person who was transferred within the District. But in respect of the petitioner, she has been transferred to a distant place of posting which will be very much inconvenient being a woman to reside therein and to serve properly. Moreover, it would further be difficult on the part of the petitioner to take care of her two minor children in absence of her husband while continuing her service at the transferred place. So, Learned Senior Counsel urged for allowing this writ petition by setting aside the order of transfer and also urged before the Court to pass an interim protection till disposal of the writ petition.

Considered.

Let the notice be issued upon the respondents.

Learned Counsel, Ms. Pinki Chakraborty appears and accepts notice on behalf of the respondents, formal notice is thus waived. At this stage, Learned Counsel sought time to take necessary instruction and to allow the respondents to file counter affidavit.

Request is considered.

The respondents are at liberty to file their counter affidavit on or before the next date.



However, till disposal of the writ petition, the order of transfer vide memo dated 25.06.2026 in respect of present petitioner namely Smt. Susmita Paul be stayed.
