Criminal Case No. 243 of 2025, presently pending before the Court of the Additional Principal Judge, Family Court, Haldwani, to the competent Family Court at Bageshwar.</p> <p>3. It is averred that the applicant is a permanent resident of Bageshwar and is suffering from 45% physical disability, on account of which he faces considerable hardship in attending proceedings at Haldwani. It is further pleaded that respondent no.2, with an intent to harass and victimize the applicant, has instituted the aforesaid proceedings at Haldwani, despite the fact that she is presently employed in Delhi and her parental residence is situated at Ranikhet. The applicant has further stated that on 21.01.2026, when the matter was listed before the Court at Haldwani, he was allegedly assaulted within the court premises by the counsel representing respondent no.2, in respect of which a complaint has been lodged before the concerned Senior Superintendent of Police.</p> |
