The present Criminal Revision has been filed by the revisionist-husband against the respondent-wife, seeking to set aside the judgment and order dated 26.02.2026 passed by the learned Principal Judge, Family Court, Haridwar in Case No. 408 of 2024, titled as "<i>Smt. Sapna Payal vs. Khushal Singh Payal</i>", on an application filed under Section 144 of the B.N.S.S., 2023, whereby the learned Family Court has awarded interim maintenance of Rs. 15,000/- per month in favour of the respondent.</p> <p>3. Learned counsel for the revisionist submits that his monthly income is Rs. 12,000/- and that he has filed an affidavit in terms of the directions issued by the Hon'ble Supreme Court in the case of "<i>Rajnesh vs. Neha</i>". It is further submitted that, ignoring the said affidavit, the learned Court below has assessed the income of the revisionist at Rs. 50,000/- per month solely on the pleadings of the respondent, without there being any documentary evidence in support thereof.</p> <p>4. A Stay Application (IA No. 01 of 2026) has also been filed with a prayer that the effect and operation of the impugned judgment and order dated 26.02.2026 passed by the learned Principal Judge, Family Court, Haridwar in Case No. 408 of 2024 be stayed during the pendency of the present revision.</p> <p>5. Issue notice to the respondent, returnable within four weeks. Steps shall be taken within one week.</p> <p>6. List after the service report is received.</p> |
