HON'BLE ARUN KUMAR SINGH DESHWAL, J.

1. When the matter was taken up, Sri Dev Kant Trigunait, learned counsel for the applicant has submitted that he has not mentioned this case in the category of parity as the case does not fall under the category of parity.
2. Learned counsel for the first informant has also submitted that this case does not fall under the category of parity. Learned counsel for the first informant has also shown the Whatsapp message of the mention slip showing that it was sent by Sri Dev Kant Trigunait, learned counsel for the applicant and this Whatsapp message was sent through Whatsapp by Sri Aman Chaurasia.
3. Sri Aman Chaurasia was summoned by this court then he apprised the court that actually the father of the applicant, Sri Paramjeet Singh, son of Sri Arjan Singh, resident of Mariaon, P.S.-Mariaon, District-Jaunpur, U.P. is known to him and he instructed him that his counsel Sri Dev Kant Trigunait, informed him that because of his engagement, he may not mention the case, therefore, he instructed Sri Aman Chaurasia, to mention the case on behalf of Sri Dev Kant Trigunait, but Sri Dev Kant Trigunait, learned counsel for the applicant, seriously disputed the aforesaid fact and also submitted that he has not given any such instructions to the father of the applicant, Sri Paramjeet Singh. Though, the act of Sri Aman Chaurasia is not proper but the court taking into account his length of practice is not passing any order against him.
4. However, this court directs Sri Paramjeet Singh, son of Sri Arjan Singh, resident of Mariaon, P.S.-Mariaon, District-Jaunpur, U.P., to

appear personally before this court on 24.02.2026 to clarify the above facts.

5. Put up as fresh on 24.02.2026.

6. The Superintendent of Police, Jaunpur is directed to ensure the presence of Sri Sri Paramjeet Singh, son of Sri Arjan Singh, resident of Mariaon, P.S.-Mariaon, District-Jaunpur, U.P., on the next date of listing.

7. **Registrar (Compliance)** is directed to send a copy of this order to the Superintendent of Police, Jaunpur, for necessary compliance.
