1. Connect this case along with Application U/S 482 No.42198 of 2024 (Rajeev Puri vs. State of U.P. And Another).
2. Heard learned counsel for the applicants as well as learned A.G.A. for the State and perused the material on record.
3. This application under Section 482 Cr.P.C. has been filed to quash the charge-sheet dated 22.07.2023, cognizance/ summoning order dated 13.02.2024 as well as entire proceedings of Case No.121 of 2024 (State Vs. Rajeev Puri and others), arising out of Case Crime No.454 of 2022, under Sections 498-A, 323, 506, 494 IPC and Section 3/4 Dowry Prohibition Act, Police Station Bhognipur, District Kanpur Dehat.
4. Learned counsel for the applicants has submitted that earlier for quashing of proceedings of Case No.121 of 2024 (State Vs. Rajeev Puri and others), between the same parties, the applicant approached this Court by means of Application U/s 482 No. 42198 of 2024 in which this Court vide order dated 17.12.2024 has referred the matter to the Mediation Centre directing the applicants to deposit a sum of Rs. 25,000/- before the Mediation Centre. It has further been submitted that the present matter is also between the same parties and the applicants are having all bona fide intentions to settle the matter amicably with the opposite party no.2 and in this regard, they desire to enter the process of mediation.
5. In view of the above, vide order dated 17.12.2024 of this Court passed in Application U/S 482 No. 42198 of 2024, the matter has already been referred to the Mediation Centre of this Court, therefore, the present matter is also remitted to the Mediation Centre with the direction that the same may be decided along with the aforesaid application U/S 482 No.42198 of 2024 after giving notices to both the parties.

6. Since, Rs. 25,000/- have already been deposited with the Mediation Centre in compliance of order dated 17.12.2024 passed in Application U/s 482 No. 42198 of 2024, therefore, there is no need to deposit any amount in the present case.

7. List this case after three months before appropriate Court along with the connected matter as well as the report of Mediation Centre.

8. As the applicants have already paid a sum of Rs.25,000/- as per the order dated 17.12.2024 of this Court in Application U/s 482 No. 42198 of 2024, no coercive action shall be taken against the applicants in the instant case till the next date of listing.
