The instant criminal appeal under Section 374(2) Cr.P.C., against the judgment and order dated 14.08.1986 passed by Additional Sessions Judge, Mainpuri in Sessions Trial No. 13 of 1985 (State v. Komil and 02 others) and connected Sessions Trial No. 261 of 1985 (State v. Kedar and 07 others) convicting and sentencing the appellants.

The present criminal appeal pertains to the year 1984 and is listed today under the caption of "Oldest Pending Cases In This High Court For Priority Hearing."

Ghiror, Police Station Ghiror, District Mainpuri and appellant No. 10 Ramesh S/o Shobha Ram, all residents of Village Datawali, Police Station-Matsena, District-Agra, within a period of three weeks.

List this appeal on 10.09.2025.
