1. Supplementary affidavit filed on behalf of applicants is taken on record.
2. Heard Shri Manoj Kumar Patel, learned counsel for the applicants, Shri Pramod Kumar Sahani, learned counsel for the opposite party no.2 and Shri O.P. Singh, learned AGA for the State-opposite party no.1.
3. This application u/s 528 BNSS. has been preferred for quashing of the impugned charge sheet dated 04.02.2023 and impugned cognizance/summoning order dated 29.03.2023 as well as entire proceedings of Criminal Case No.33303 of 2023 (State Vs. Sanjeev Srivastava and another), arising out of Case Crime No.365 of 2022, under sections 406, 504, 352, 506 of IPC, Police Station Shahpur, District Gorakhpur, pending in the court of learned Civil Judge (Senior Division)-Ist, Gorakhpur.
4. It is contended by learned counsel for the applicants that applicants and opposite party no.2 have entered into compromise and certified copy of the compromise has been filed along with the supplementary affidavit, which is on the record. He further submits that said compromise needs to be verified by the learned court concerned and he prays that same may be sent to the court concerned i.e. learned Civil Judge (Senior Division)-Ist, Gorakhpur.
5. On the other hand, learned counsel for opposite party no.2 as well as learned AGA for the State have no objection to the above submissions of learned counsel of the applicants.
6. In view of the above, office is directed to send the certified copy of compromise to the court concerned i.e. learned Civil Judge (Senior Division)-Ist, Gorakhpur, for verification of the same. The applicants and opposite party no.2 are directed to appear before the court concerned on

09.10.2025.

7. Learned court concerned i.e. learned Civil Judge (Senior Division)-Ist, Gorakhpur, shall verify the compromise in the presence of both the parties and submit a compromise verification report to this Court, within two weeks thereafter.

8. Learned counsel for the applicants may also file a supplementary affidavit bringing on record the proceedings of the compromise, within two weeks, after verification of the compromise.

9. List this case on 06.11.2025 as fresh, before the appropriate Bench.

10. Interim order granted earlier shall continue to operate till the next date of listing.
