5. The department is directed to trace out the affidavit filed by the State in WPA (P) 442 of 2023 affirmed by one Mr. Shiladitya Chakraborty on 25th September, 2023. It

appears from the order dated 27th March, 2025 that the said affidavit was on record.

6. Hence, the department is directed to immediately trace out the affidavit and must ensure that the said affidavit is available on the adjourned date.
